It's always a great time to be a Member in the Association as many projects are being completed (or are ongoing) to enhance our lifestyle here in Lake Sherwood. I will offer a suggestion that everyone look at the "Who We Are" section of our Website. It can be found under the "About Us" tab on the front of the website, and I believe this captures the essence of the Lake Sherwood Homeowners Association and also gives insight into what motivates everyone to continue contributing, collaborating and putting forth the social & physical effort that makes our neighborhood so desirable. I believe our Board as a whole embraces these values & principles in every decision we make.

The recent Annual Membership meeting back in October was well attended and many subjects were discussed & shared with the Membership. The Budget was approved for 2024 with dues holding steady @ \$400, new Area Reps have been elected in Areas 2 & 6, updated By Laws were approved (more to come), and several projects have advanced into the "active" phase to improve Lake Quality and care of the Association Property. The Wildwood Canal project has moved forward slightly

with more testing done for EGLE and 2 devices were installed this season at the head of the canal for performance evaluation to limit organic accumulation at one of the main sources. The Kendall Park Preservation Committee conducted several improvements/ upgrades this year, and more are in the works with input from the residents, and their 5 year plan is submitted. Skier's Island has been reseeded, two new trees have been planted, and other improvements are being implemented and tested (goose control, wave deflector, and landscaping improvements) to further improve/restore the Island. Lake Quality has a new Committee that is taking a critical look at the water with multiple approaches & analysis that I believe will provide a significant benefit to the waters moving forward. There are many other projects and improvements ongoing and diligence by our wonderful volunteers is acknowledged and appreciated to keep things moving in the right direction. I cannot stress enough how important the Volunteers are in the Association to continue care & maintenance of the Association's assets, and the more that get involved the more TLC the Association as a whole benefits from the cumulative efforts.

With the extraordinary weather events of late summer adding a significant amount of water to the

Water Quality

The 2022 Dues Survey says: "We the residents of Lake Sherwood care deeply about the health of our lake". In fact, water quality was the number one priority of residents. As a result, a new committee consisting of 10 residents was formed to address this issue.

Members include: Dan Devine, TJ Gurski, Bill Kevelin, Carolyn Kevelin, Jeff Mauer, Julie Race, Mike Schwartz, Leslie Thomas, Linda Tucker, and Carol Wilkop.

Before the committee was formed, there were many efforts already underway to address lake water improvements including:

- Two different versions of muck eating apparatus installed near the Wildwood River entrance
- Permitting and hopeful dredging of the Wildwood River entrance
- Installation of 34 EutroSorb bags in the culverts around the lake
- Sponsorship of mandatory septic tank/field inspections upon the sale of a residence in Commerce Township
- Dr. Jude's scientific collection and assessment of lake samples
- Working with Huron Valley School Board to address the run-off coming from Oak Valley and the lack of natural filtering and a retention basin
- Working with municipal and county representatives to address aging storm drain infrastructure
- Working with developers north of the lake to reduce run-off.

Many great volunteers are spearheading these efforts and collectively they will gradually improve our water quality.

Many residents are grateful for these efforts but ask what they can do individually to assist. The Water Quality Committee will have a dedicated page in this View and subsequent issues where we will pick a topic and provide some details. You will find the first of these articles later in this issue of The View.

Lakeland High School but didn't know each other yet! They currently reside in Howell.


Water Quality - Natural Shoreline Vegetation

In each issue of The View, the Water Quality Committee will address different topics that residents can pursue to help improve the water quality of our lake. For our first topic, let's look at natural shoreline vegetation.

For those that attended the fall General Membership Meeting, you heard T. J. Gurski mention the importance of natural shoreline vegetation. Natural vegetation is comprised of native plants that typically have extensive root systems which help hold the soil in place better than non-native plants such as turf lawn. Natural shoreline vegetation slows down water runoff from a sloping yard or landscape to allow pollutants such as sediments, contaminants and fertilizer to be absorbed before they reach the water. Keeping these nutrients from the water also helps keep the water clear of algae. Natural shoreline vegetation provides key habitat for wildlife too.

Shoreland Stewards Program sponsored by Michigan Natural Shoreline Partnership is an organization that recognizes the importance of a shoreline containing native plantings. Overdeveloped lakeshores have a difficult time supporting fish, wildlife or CLEAN water. A large waterfront lawn with few trees, shrubs, wildflowers, aquatic plants or logs is a perfect invitation for geese and the mess they leave behind. The Shoreland Stewards Survey is a tool lakefront property owners can use to assess their own property to see if they are contributing to a healthy lake or if their property is a detriment. A high score on the survey indicates a healthy shoreline. A low score indicates your property could use some improvements. The site gives information and suggestions on what you can do to improve your property and, in turn, improve the health of our lake.

The Water Quality Committee recommends that residents take the survey found at <u>mishorelandstewards.org/rate.asp</u>. Additionally, the website <u>shorelinepartnership.org</u> is a wealth of information on creating and maintaining healthy shorelines. Please give this some thought and start planning your buffer zone plantings for next spring to help ensure a healthy lake for years to come!



Lake Sherwood General Membership Meeting October 4, 2023 Oak Valley Middle School 6:30 P.M.

Attendance- 58 households represented in attendance.

President- Steve Biebel called the meeting to order at 6:45. We have an official quorum.

- Tim and Amy Carpenter introduced themselves as new members.
- Approval of July General Membership Meeting minutes, Brad Hynes made motion to approve minutes as written, 2nd by Dave Von Behren, minutes adopted.
- Introduction of those on the ballot.

Vice President- Jody Payne

Thanked and acknowledged those who volunteer, and said we are always looking for more volunteers.

Treasurer- Paul MacDonald

- ☐ The Board recommends keeping the dues at \$400 per residence. There will be approximately \$400,000 in cash reserves at the end of 2023. Brad Hynes made a motion to approve the presented budget and to hold the dues \$400 for 2024. Andy Sarkisian 2nd. Motion approved.
- Budget- still some unknown bills for 2023 and committees are working on their projects and forecast.
- Beautification committee has an overrun in the "trees" line of the budget due to a couple large storms. Andy Sarkisian made a motion to add \$4,000.00 to the 2023 budget for ongoing grounds maintenance. Brad Hynes 2nd. Motion passed.

Recording Secretary Diane DeVincent had no report at this time.

Corresponding Secretary Thea Vagiates is looking for ideas for the View publication from all members. **Ballot Results** - Todd Wood announced that all listed on the ballot unopposed won their positions. Mike Krafchak won for Area 2.

Ad Hoc Committees:

Wildwood Canal- Gary Koch

- 2 different kinds of pods were added in the canal to test for a long-term solution to reduce muck buildup. Will hope to have results for comparison in the Summer of 2024.
- Dredging- took 12 samples last fall, 8 out of 12 are over the contaminants limit. EGLE wants 8 more testing samples with a different analysis. Still waiting for an approval by the State for dredging.

By-Laws- Kathy Sawicki

Phase 1 of the By-Law updates to be voted upon. They haven't been updated in 20 years. The original By-laws were adopted in 1987. Karen Adams made a motion that the By-Law amendments as printed in the View be adopted. Dan Devine 2nd. Motion passed.

Standing Committees:

Water Boat Safety Nick Polcyn

- We had a good year with no accidents. There are safety classes online. Any motorized boat operator born after June 30th, 1996, is required by law to pass a boater safety course and to carry a boater education card. In addition, boater education is also required for all PWC operators born after December 3, 1978.
- Buoys are planned to be pulled out on October 14th.
- Mooring buoys are not encouraged as they can be a navigational hazard.
- Surfboat patterns are being monitored for safety.

Wakes- look behind your boat to monitor what kind of wake your boat is making while traveling in the canals and slow down if necessary.

Water Quality- TJ Gurski and Dan Devine

- They have started a committee with 10 members to evaluate ways to improve our water quality. They broke up the tasks amongst the members, i.e., historical data, Secchi disk readings, satellite imaging comparisons, government agencies- large watershed and the impact on the lake, comparisons to other shallow lakes, and Eutrosorb bags.
- Score the Shore"- encouraging homeowners to make a natural, native planting garden to buffer along the lake shore.
- Make a dedicated page in the View that would offer informational suggestions for homeowners to improve water quality.

Boat Ramp- Todd Wood

- Boat ramp is running smoothly overall. There were definitely issues, but they are being worked through.
- Residents asked to make sure you close the gate after using the ramp (this includes 3rd party haulers).
- The Ramp will be open till mid-November. Remember, the water level will drop 18" in early November, so use caution.
- If you get a new boat or sell a boat, make sure to notify the committee of the changes.

Beautification/ Lawn Care- Karen Adams

- There will be plantings done on Ledgewood in the fall.
- U Weather conditions will warrant that Lawn Care goes till mid-November.
- Cul de sacs will get some weeding services.

Another year of open water fishing on Lake Sherwood draws to a close. There are many of us out there who have quietly enjoyed an early morning or evening casting the shoreline hoping to catch a fish or two.

The fishing continues to evolve. I hear quite a few reports that people are not catching as many fish as they used to. I would agree. Why is this? With so few weeds, it is more difficult to find fish. They are not localized. They are in one location today and gone tomorrow. It can take time to locate those schools of fish, but I would say, keep at it. Keep moving, try different presentations because often when you find them, it can be a real bonanza.

Additionally, I believe the lake is being fished harder and by better fishermen than in the past, making it more difficult for the casual angler to be successful.

Observations:

Many clouds of newly born fish observed in the spring Lots of very healthy bass. More 16" - 18" fish than in past years. Small pike numbers substantially down Several trophy pike over 40" reported Very few keeper size bluegills Walleyes continue to be caught in limited numbers with several over 25" fish reported There are some huge crappie but they can be elusive Compared to other local lakes, Lake Sherwood is still a great fishery

Ice Fishing Pass Process

- Ice access for recreational purposes is restricted to Lake Sherwood residents and their guests.
- A Lake Sherwood resident must accompany any guest who is on the ice to fish. (We are willing to make exceptions to this rule if a resident is physically unable to accompany the guest.)
- Any Lake Sherwood resident who wishes to ice fish must be in possession of an Access Pass.
- Any Lake Sherwood resident using an A-Lot to access the lake must display a Lake Sherwood Parking Pass in their vehicle on the dashboard.
- The Access Pass and Parking Pass will be provided and controlled by the Lake Sherwood Fisheries Manager or his/her designate.
- Each Access Pass will identify the specific property owner.
- The Access Pass will allow lake access for ice fishing to the resident and up to four guests via a Lake Sherwood Association A-lot or the resident's property. If additional guests are invited to be on the ice to fish, a call to the Fisheries Manager or his/her designation in advance is required.
- If approached by any Lake Sherwood resident, the fisherman must show (or identify the resident they are fishing with) this Access Pass and identify those in his/her party.
- It is the responsibility of the Lake Sherwood resident to request passes from the Lake Sherwood Fisheries Director or his/her designate.
- A Lake Sherwood resident granting ice access to guests for any purpose will be held responsible for the conduct and actions of their guests. If guests are in violation of any rules or regulations set forth by the Lake Sherwood Association or the State of Michigan, they will be asked to leave the lake property and the resident's Access Pass, if any, will be revoked. The Sheriff may also be requested to intervene. Access Passes for ice fishing will be issued only to those residents who are current with Lake Sherwood dues. If a resident loses the Access Pass or Parking Pass, they will be issued a replacement pass at a cost determined by the Lake Sherwood Association Board.





Reminders

Allow up to two weeks after you pay your annual dues for your card to be activated in the Spring. Please pay your dues before March to ensure a smooth process.

A-Lot users, allow up to two weeks after you turn in your annual A-Lot form for your card to be activated in the Spring.

If you have a new watercraft, please send proof of ownership (pic of registration) to a member of the boat ramp committee (or email boatramp@lake-sherwood.org) to ensure your access card is activated.

If you are a new resident, the boat ramp access card that you may have from the previous owner will not work in the Spring. You must fill out a Boat Ramp User Agreement (Go to www.lake-sherwood.org then pick the Lake Life menu and select Forms) and provide proof of ownership of your watercraft. Please contact a member of this committee (or email boatramp@lake-sherwood.org).



This year we've been able to create five new larger slips to accommodate pontoons. There are currently 7 REGULAR SLIPS AND 3 LARGE SLIPS open around the lake (see map on website for locations). A site-survey of all A-Lot docks is nearly complete, and slip users will receive a notice from the committee should your dock need attention.

Below is the Dock Specification sheet to refresh your memory regarding the rules:

A-LOT DOCK SPECIFICATIONS LAKE SHERWOOD ASSOCIATION

DOCKS:

SAFETY is the prime concern. The docks are to be maintained with safe and stable decks with no protruding fasteners or broken/cracked boards. All stringers are to be sound – not cracked or bent. The deck must be level within 2" side to side.

APPEARANCE: The docks should be sell maintained and as similar as practical to other docks on the A-lot. The docks will be maintained with the original wood/other surface (no paint or colors). Commercially available bumpers and fenders are allowed. But no tires or other materials are allowed.

RECOMMENDED SPECIFICATIONS:

Width: 30-36'

Length: 16-30' except as approved by the A-lot Committee Height: The deck surface must be above the water level Materials/Construction: Commercially available wood, aluminum, composite or vinyl docks (recommend 2" nominal thickness treated deck surface if wood). Poles to be commercially available (recommend 2" galvanized steel with screw bases).

LIFTS:

Lifts may be placed in a slip ONLY WITH THE ADVANCED WRITTEN APPROVAL OF THE A-LOT COMMITTEE, space permitting. No lift over 10' in width is permitted. The Leafwood and Starwood a-lots are currently designated as NO-LIFT A-LOTS due to shallow water and dock spacing. Unapproved lifts and approved lifts not placed entirely within the user's own slip will be removed/moved at the slip user's expense.

The A-Lot Dock Committee reserves final approval rights for lift placement in order to assure appropriate allocation of slip space among Lake Sherwood off-water property owners, and to promote the general appearance of all A-Lots

NOTES:

Dock/slip users must register their slip every year with the A-lot Committee. Unregistered slips may be reassigned.

An unsafe or dilapidated dock or lift will be removed/repaired at the slip users' expense. No personal property, i. e. boats, lifts, trailers, kayaks, may be left on A-lot property. Lifts and boats on a lift may be left in the water over the winter from November 1 to March 31 (not recommended where ice damage may occur). Boats left on lifts over the winter must be shrinkwrapped or have covers in good condition and tightly secured (User is responsible for this at all times). You must register your winter storage by indicating so on the Annual Registration form each year.

In an effort to help with the water quality, PLEASE pay attention to the lake bottom around your slip. If there are leaves, vegetation rotting, etc., please do your part and rake it out.

Phragmites

Dan Devine and I went out on the lake in early October to map areas in Lake Sherwood that have phragmites. Lake Sherwood Association can only treat phragmites that are in the water. If they are on your property, please treat them to eradicate them.



Phragmites are very invasive weeds that need to be destroyed. They are also a fire hazard especially in the late fall/winter when they turn brown. They are hollow reeds and burn very hot.

In the Spring, if you have phragmites on your property or waterfront, you can cut them down to the ground or below the water line. If you keep the phragmites cut below the waterline or dirt line all summer, they won't sprout seed heads. If they are still growing and green by August, you can treat them with RoundUp.

They feed their roots late in the season so the herbicide will go to the roots. It takes three years of regular treatment to eradicate them. The plant feeds the roots late summer, early fall and that is the best time to treat with an herbicide so it gets into the roots. It is important to <u>bag the seed heads</u> before you cut them down when they turn brown.

It is important to keep them out of our lake. They can take over in a very short time, crowding out native plants and destroying animal and fish habitat.

The current forecast expects us to come in under budget by around \$37,000. As we've discussed at a few other meetings, these savings will eventually be used for some of the major upcoming projects (ie: seawalls and lake quality).

We've collected Dues from all but 9 of the 631 members (and one more "promise to pay"). Thank You to all those that have paid! This is imperative to keep the Association running smoothly.

- With interest rates rising, we have moved some funds into a secure savings account that will net some additional earnings.

- We expect to be under budget in the Lake Weed Control area by about \$26,000 due to less weed treatments needed.

In the Lakes Committee section, we had budgeted for some work at the boat ramp that wasn't needed resulting in a positive \$4,000, along with a few other areas that should come in under budget (marine patrol, well pump, utilities, etc).

Because several of the projects have been delayed over more than one budget year, the Board is going to forecast the expenditures in the year budgeted, and then earmark a reserve for the future cash outlay. The "Water Quality/Dredging" project is the largest of these, and the reserve is approximately \$31,600. Several other items amount to approximately \$23,000.

We expect to have unencumbered cash of approximately \$370,000 at 12/31/23 after spending the forecasted amounts above.

*** 2024 Approved Budget Notes. (As presented and voted on at the Annual Membership Meeting in October.)

- The Board recommended holding the 2024 annual dues at \$400, and the membership approved at the Annual meeting. This would result in a small amount of Net Income, but there is always a chance of overruns given the complexities and age of the subdivision.
- One of the larger items in our budget every year is the weed treatment for the lake, and we anticipate that we can hold that at the same amount as the 2023 budget. This line will also be used for the Eutrosorb bag concept that was implemented in 2023, and Phragmite eradication if needed.

The Water Quality / Wildwood River issue is still delayed. Once we satisfy what EGLE requires and obtain a permit, we can move forward. Due to the uncertainty surrounding this project, we aren't budgeting any additional dollars in 2024, but we are going to implement some new concepts to help contain the problem (ie: the Bio-Health Pod System). As noted above, there is a reserve already for this, but we may need to request additional funding if the project scope or pricing changes.

The Beautification line has a new amount to improve the look of the Surfwood isthmus that faces both the lake and the ramp bay.

There is a newly formed Island Committee that began in 2023. This group has presented the Board with a 5-year plan to maintain and improve the various islands. In the not so distant future, this will include seawall replacement at the islands in need. Although there is not a proposed budget for all 5 years, there has been significant thought put into the possible needs, and when to act on them. The \$19,150 budget for 2024 includes a possible sun shelter on Skier's Island, follow-up work on the shoreline barriers at Sunset Island, goose

droppings cleanup, dock install/removal, and other smaller items.
